Our lectures are delivered mainly in Catalan and Spanish. Some master lectures are delivered in English. We do require exchange students to certify a B1 of Spanish language. We expect exchange students who will take courses to be able to follow the lectures. Therefore we strongly suggest all incoming students to prepare their knowledge of Spanish or Catalan thoroughly before coming to Barcelona. The exams are generally in Catalan or Spanish and there is no guarantee that our teacher will offer the option of taking it in English.

2. The receiving institution will send its decision within [5] weeks.
3. A Transcript of Records will be issued by the receiving institution no later than [5] weeks after the assessment period has finished at the receiving HEI. *[It should normally not exceed five weeks according to the Erasmus Charter for Higher Education guidelines]*
4. Termination of the agreement
[It is up to the involved institutions to agree on the procedure for modifying or terminating the inter-institutional agreement. However, in the event of unilateral termination, a notice of at least one academic year should be given. This means that a unilateral decision to discontinue the exchanges notified to the other party by 1 September 20XX will only take effect as of 1 September 20XX+1. The termination clauses must include the following disclaimer: "Neither the European Commission nor the National Agencies can be held responsible in case of a conflict."]
