The P AVEIRO01 will send its decision on the admission of ERASMUS candidates within 4-6 weeks.

3. A Transcript of Records will be issued by the TR ISTANBU07 no later than 4 weeks after the assessment period has finished at the receiving HEI.

A Transcript of Records will be issued by the P AVEIRO01 no later than 5 weeks after the assessment period has finished at the receiving HEI.

### 4. Termination of the agreement

The present agreement is valid for a period mentioned above. This agreement may be amended or modified by a written agreement signed by the representatives of both Universities. It may be renewed on the same terms, or on such terms as may be agreed by the two institutions.

This agreement may, at any time during its period of validity, be terminated by one of the Universities upon prior notice to the other in writing not later than one year before the termination date, without prejudice to the activities under way.

Neither the European Commission nor the National Agencies can be held responsible in case of a conflict.
