YILDIZ TECHNICAL UNIVERSITY

YTU does not require any certificate for language proficiency although a good command of English language is highly recommended. The language of instruction is both English and Turkish. 30% of the curriculum is conducted in English language and students are free to choose the courses depending on their skill in both languages (Turkish, English). Erasmus students are provided –without any chargewith Turkish Language Course at three different levels: Beginner (Fall & Spring), Pre-intermediate (Spring only), Advanced (Fall & Spring).

NTU Athens, School of Architecture

There are not any courses given in English in the curriculum of the School, except for one which is organized every year especially for the Erasmus students. However, there is no requirement for exchange students to know Greek – on the contrary, a good level of English is strongly recommended. Given that our Erasmus students very rarely can understand the language before coming to Athens, alternative solutions for them are always available (corrections in English, international bibliography etc). The exchange students are not obliged to written texts or written exams in Greek. We must also notice in addition to these, that almost everybody -professors as well as students- speak English (very often also a second foreign language, which usually is French, Spanish or German). Moreover, for those of the exchange students who wish to get familiar to the language, Greek language courses for beginners and/or advanced students are organized, free of charge, every year.

 The students are required to consider the up-to-date call for applications following their
 nomination to YTU.
- Incoming students are invited to YTU starting from 01.09 to 01.02 (Fall) and 01.02 to 01.07 (Spring) considering that they may need a period of adaptation before starting the academic semester.

- Orientation Programme/Week is organized on the first day of the semester in coordination with ESN YTU.
- Student Buddy System is organized by ESN YTU and each incoming student will have a buddy among YTU students all throughout their Erasmus stay at YTU.

NTU Athens, School of Architecture

- 1. Mobility flows: At NTUA, School of Architecture, student mobility numbers may be divided into separate semesters (each academic year is divided into two semesters one semester is 13 weeks of teaching followed by 3 weeks of exams).
- 2. Academic calendar: Exchange students are advised to be in Athens until 01.10 at the latest for a fall semester or whole year mobility, and until 15.02 at the latest for a spring semester mobility. They do not have to be present on campus until the very end of the semester, but can in most cases leave after the end of their final lectures or exams.

- 4. Student Buddy System: ESN Greece organizes a Welcome Buddy System. Incoming students can opt for a buddy upon application.
- 5. The institution has the infrastructure to welcome students and staff with disabilities.

NTU Athens, School of Architecture

1. Application procedure: The documents necessary to apply for an Erasmus mobility to Athens School of Architecture are sent, after the nomination of the incoming students, to the students themselves as well as to the international offices of the partner Universities. The filled-in documents should be sent back directly to the Erasmus office of the School, by e-mail to the address evarouchaki@arch.ntua.gr. Then, a letter of acceptance is sent both to the students and their home Universities.

Information material about the School, as well as about the study curriculum, can be found on www.ntua.gr (site of the University) and www.arch.ntua.gr (site of the School). For information about the application procedure (documents: application forms, language courses and accommodation) please see at http://erasmus.ntua.gr (in English). For personalized information, details or any other request, please address an e-mail message to the Erasmus Office of the School of Architecture (evarouchaki@arch.ntua.gr).

- 2. Letters of acceptance: NTUA, School of Architecture will send its decision no later than 4 weeks after the above mentioned deadline.
- 3. Transcript of Records: A Transcript of Records will be issued by NTUA, School of Architecture no later than 10 weeks after the assessment period has finished.
- 4. Termination of the agreement

[It is up to the involved institutions to agree on the procedure for modifying or terminating the inter-institutional agreement. However, in the event of unilateral termination, a notice of at least one academic year should be given. This means that a unilateral decision to discontinue the exchanges notified to the other party by 1 September 20XX will only take effect as of 1 September 20XX+1. The termination clauses must include the following disclaimer: "Neither the European Commission nor the National Agencies can be held responsible in case of a conflict."]

In case of termination, a notice of at least one academic year should be given. This means that a unilateral desicion to discontinue the exchanges notified to the other party by 1 September of one academic year will only take effect as of 1 September of the following academic year. The termination clauses must include the following disclaimer: "Neither the European Commission nor the national Agencies can be held responsible in case of a conflict".

In the event that notice of termination of the agreement is given, students who have already been selected and accepted for the exchange program may still participate. Notwithstanding the termination of the agreement, each institution agrees that it will continue to fulfill its responsibilities to exchange students already registered at their institution until the completion of their particular exchange period.
