d- d A knowledge of the Italian language corresponding to B1 level is strongly recommended to attend courses in Italian. Officially no certification is required, but some Schools may ask for it, so please address the Erasmus coordinator of the hosting School (http://www.unifi.it/vp-743-school-coordinators.html) for further information on language certification requirements when nominating your outgoing students.

e Student mobility for traineeship purposes (SMP) is possible only upon specific or individual agreement (Letter of Intent) between the sending and the hosting School/Department.

- 4. Termination of the agreement
