Issue of the Transcript of Records

RO TIMISOA04: Transcript of Records will be issued by our university no later than 5 weeks **after the assessment period has finished**. The original document will be sent by the Department for International Mobility and Cooperation to the home university using regular mail services. A scanned copy will be sent by e-mail to the student and to the home university.

TR ISTANBU07: A Transcript of Records will be issued by the receiving institution no later than [4] weeks after the assessment period has finished at the receiving HEI. [It should normally not exceed five weeks according to the Erasmus Charter for Higher Education guidelines]

4. Termination of the agreement

The involved institutions agree on the procedure for modifying or terminating the inter-institutional agreement. In the event of termination, a notice of at least one academic year should be given. Neither the European Commission nor the National Agencies can be held responsible in case of a conflict.
