- Ensure recognition for satisfactorily completed activities of study mobility and, where possible, traineeships of its mobile students.

Ensure that outbound mobile participants are well prepared for the mobility, including having attained the accessary level of linguistic proficiency.

Insure that student and staff mobility for education or training purposes is based on a learning agreement for tudents and a mobility agreement for staff validated in advance between the sending and receiving nstitutions or enterprises and the mobile participants.

- Provide assistance related to obtaining visas, when required, for incoming and outbound mobile participants.

- Ensure equal academic treatment and services for home students and staff and incoming mobile participants
 and integrate incoming mobile participants into the institution's everyday life, and have in place appropriate
 mentoring and support arrangements for mobile participants as well as appropriate linguistic support to
 incoming mobile participants.
- Accept all activities indicated in the learning agreement as counting towards the degree, provided these have been satisfactorily completed by the mobile student.
- Provide, free-of-charge, incoming mobile students and their sending institutions with transcripts in English or
 in the language of the sending institution containing a full, accurate and timely record of their achievements
 at the end of their mobility period.
- Support the reintegration of mobile participants and give them the opportunity, upon return, to build on their experiences for the benefit of the Institution and their peers.
- Ensure that staff are given recognition for their teaching and training activities undertaken during the mobility period, based on a mobility agreement.

- 2. The receiving institution will send its decision within 4 weeks.
- 3. A Transcript of Records will be issued by the receiving institution no later than 4 weeks after the assessment period has finished at the receiving HEI. [It should normally not exceed five weeks according to the Erasmus Charter for Higher Education guidelines]
- 4. Termination of the agreement

[It is up to the involved institutions to agree on the procedure for modifying or terminating the interinstitutional agreement. However, in the event of unilateral termination, a notice of at least one academic year should be given. This means that a unilateral decision to discontinue the exchanges notified to the other party by I September 20XX will only take effect as of 1 September 20XX+1. The termination clauses must include the following disclaimer: "Neither the European Commission nor the National Agencies can be held responsible in case of a conflict."]
