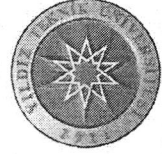

CZ BRN001: Programmes and courses that are offered for exchange students are open to qualified students, nominated by their home university as exchange students; students are required to arrive in time for the beginning of the semester.

Welcome Activities: The Brno University of Technology organizes an orientation program a week before the classes for the semesters start.

Faculty of Civil Engineering of BUT has barrier free access; students on wheelchair can attend courses at the faculty. We can guarantee individual approach to such a student. Acceptance and further arrangements need to be agreed in advance.

2. The receiving institution will send its decision within [4] weeks.
3. A Transcript of Records will be issued by the receiving institution no later than [4] weeks after the assessment period has finished at the receiving HEI. The host university will report the transcript of records from each visiting student to the home university using the English language.

[It should normally not exceed five weeks according to the Erasmus Charter for Higher Education guidelines]

4. Termination of the agreement

[It is up to the involved institutions to agree on the procedure for modifying or terminating the inter-institutional agreement. However, in the event of unilateral termination, a notice of at least one academic year should be given. This means that a unilateral decision to discontinue the exchanges notified to the other party by 1 September 20XX will only take effect as of 1 September 20XX+1. The termination clauses must include the following disclaimer: "Neither the European Commission nor the National Agencies can be held responsible in case of a conflict."]


