TR ISTANBU07

- Exchange students should be nominated by the home institution.

- YTU provides infrastructure for welcoming students and staff with special needs.

RO CONSTAN03:

- students' transcript of records for previous semesters of study completed before the exchange shall be submitted as obligatory form with regular application
- LA shall cover academic activities for min. 20 ECTS per semester
- missing classes = no entry to exams session (unless a notice on serious reason of absence is sent to the academic coordinator at particular faculty and to Erasmus Office)

normally not exceed five weeks according to the Erasmus Charter for Higher Education guidelines]

4. Termination of the agreement

[It is up to the involved institutions to agree on the procedure for modifying or terminating the inter-institutional agreement. However, in the event of unilateral termination, a notice of at least one academic year should be given. This means that a unilateral decision to discontinue the exchanges notified to the other party by 1 September 20XX will only take effect as of 1 September 20XX+1. The termination clauses must include the following disclaimer: "Neither the European Commission nor the National Agencies can be held responsible in case of a conflict."]
