PL KIELCE02

- 1. Before sending application documents, students must be officially nominated by their home university. We may accept late applications upon agreement of both parties.
- 2. The nomination should be sent to the International Relations Office and include the following information:
- name and surname of the nominee
- date of birth
- e-mail
- gender
- field of study/academic area
- level of study

- 3. Exchange students are encouraged to participate in orientation sessions which are held at the beginning of each semester.
- 4. Support is offered to students and staff with special need or disability.

- 2. The receiving institution will send its decision within [4] weeks.
- 3. A Transcript of Records will be issued by the receiving institution no later than [4] weeks after the assessment period has finished at the receiving HEI. [It should normally not exceed five weeks according to the Erasmus Charter for Higher Education guidelines]
- 4. Termination of the agreement

[It is up to the involved institutions to agree on the procedure for modifying or terminating the inter-institutional agreement. However, in the event of unilateral termination, a notice of at least one academic year should be given. This means that a unilateral decision to discontinue the exchanges notified to the other party by 1 September 20XX will only take effect as of 1 September 20XX+1. The termination clauses must include the following disclaimer: "Neither the European Commission nor the National Agencies can be held responsible in case of a conflict."]

The Polish grading system in higher education is based on the 5 to 2 scale, where 5 is the best mark and 2 is the worst. Moreover, students can also be marked with additional sign of + which equals half a point: + means 0.5 more. Some courses, however, are not evaluated on such a marking scheme and

for these a student may simply obtain zal. or zaliczenie which means that their workload was satisfactory and they have passed the course.
