**among EU Member States and third countries associated to the Programme**

The institutions agree to cooperate for the exchange of students and/or staff in the context of the Erasmus+ programme. #### Termination of the agreement

*"Neither the European Commission nor the National Agencies can be held responsible in case of a conflict."*
